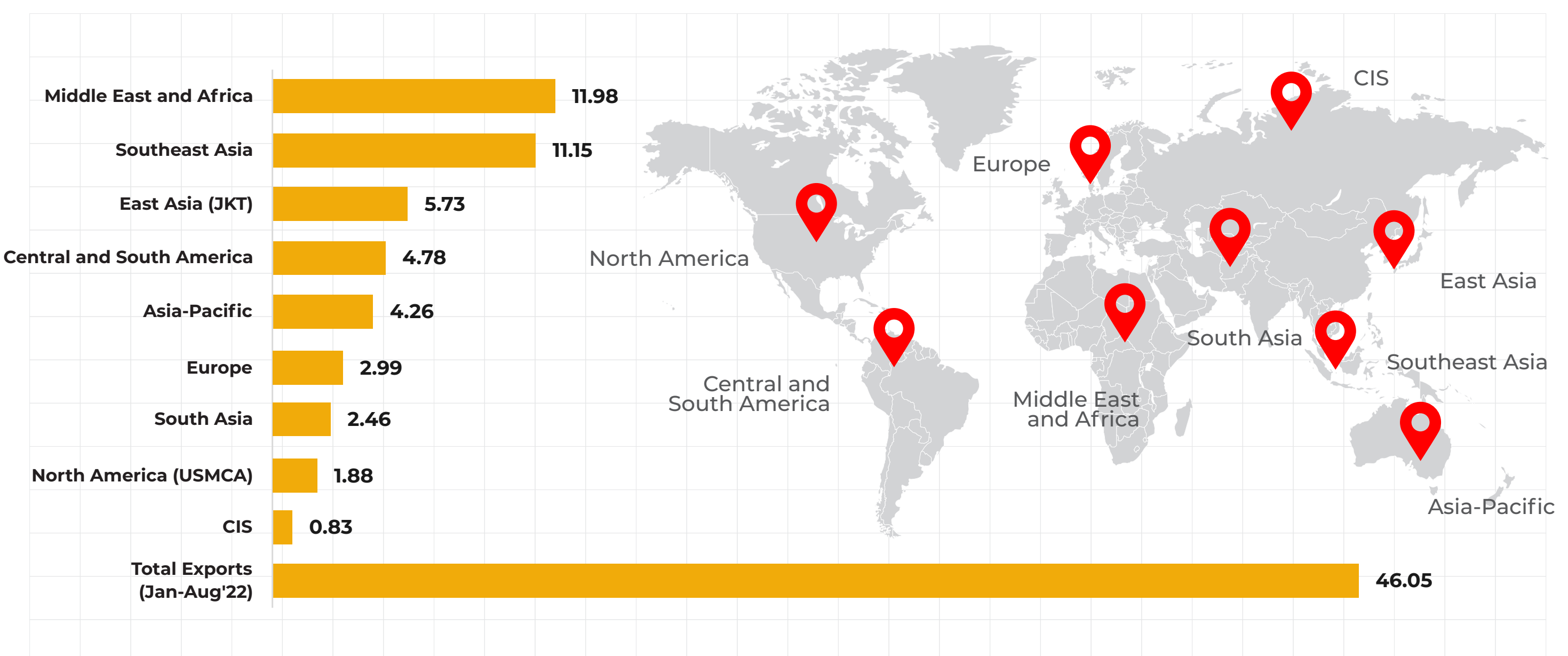


China's Region-wise Steel Exports Jan-Aug'22
